Shelter Manager's Report

2008 was a busy and fun filled year at CASA with all of the successful events, many adoptions and volunteer involvement.

In the last six months many positive changes have been accomplished. CASA staff are now drawing blood for FELV testing and sending the samples to Phoenix Central Lab for results. Up and coming is a donated microscope to begin testing for fecal parasites but also test for various types of skin disorders. These tests not only enhance what CASA staff is capable of doing, they save money on other tests that are needed.

CASA staff members took a class on Washington State Laws and Ordinances pertaining to animal issues. Having this additional knowledge will aid them as they interact with and educate the public.

The staff has also been given 12 hours of professional training in dog obedience classes. The training was donated by Camano Island Kennels and conducted by its owners, Jason and Dianna Young. The shelter's dogs went through the training with staff and this has helped tremendously in lowering the dogs' stress levels. It also has produced better behaved dogs and that will lead to quicker future adoptions.

In the month of December, during the snowstorms and low temperatures, shelter staff was dealing with frozen water and one kennel heater not functioning. The weather forecast was for high winds and more snow. Just to be on the safe side, the decision was made that it was best to foster out our dogs instead of leaving them at the CASA location. Tony Cloud of Cloud's Canine, Jason and Dianna Young of Camano Island Kennels, and CASA volunteers Terry and Ayleen Bauman all offered to foster some of CASA's dogs. Staff member Phyllis Kidwell fostered our "Miss Marigold". Oddly enough, no impounded dogs came into the shelter during this time. The small, young kittens went with staff into foster care while the older cats were given extra bedding, water, food and litter boxes and remained at the shelter with the heat turned up. For several critical days, all of our CASA "kids" were cozy, warm and having an enjoyable holiday. Staff members have some interesting stories to tell about having cars stuck and being marooned in various places because of the snow, but in spite of these challenges they managed to be on the job daily to tend to the animals and keep the shelter up and running. A special "Thank You" goes to staff, fosters and volunteers for rallying in a time of need. The generous gestures of concerned community members, private citizens and businesses, demonstrate how CASA's animals and employees benefit.

As Manager, I have a goal and desire along with the staff, Board members and volunteers to see CASA become the best shelter in Western Washington. After this is accomplished we then can strive to become the best in Washington State. With everyone's support this goal can become a reality.

Marigold's Story

Marigold is a large 5 year old Alaskan Malamute/Shepherd mix who was brought into CASA together with her sister as strays on April 4th, 2008. Neither Marigold nor her sister was spayed. So as a first order of business, CASA made arrangements to have that done. Within a relatively short time, both sisters were adopted together by a family here on the island.

Unfortunately they were returned to CASA within 2 weeks. Apparently the

new owners were not prepared to deal with a rambunctious pair of dogs each weighing over 100 pounds. Shortly after their return Inia, Marigold's sister, was transferred to another shelter where she was quickly adopted and placed in a new home where it has been reported that she is doing very well. Everyone at CASA was happy that Inia had found her Forever Home.



But sadly, Marigold found her sister's leaving hard to deal with. She became guiet and depressed. She and Inia had been very attached to each other. She adjusted to being on her own, but it took quite awhile 4 for her to adapt.

When Marigold was given the standard temperament test that all dogs at CASA receive, it was discovered that she had an obsession with cats. It was recommended that she only be adopted into a home without cats. She also had a fear of riding in cars and refused to get into a vehicle unless she was physically forced into it. This wasn't easy to do since she weighs 125 pounds.

Several months ago the dogs at CASA were enrolled in obedience/behavioral training. Classes were held one day a week with as many dogs participating as there were people to work with them. During these classes Marigold blossomed into a star student. She learned to walk well on leash, understood and followed instructions for all basic commands, and learned to enjoy the company of the other dogs in class with her. 

Recently, during the December snowstorms, Marigold went into foster care with a CASA staff member who has one cat and a small dog. Neither of these pets was excited having a houseguest of Marigold's size. All three were closely supervised on the first day. By the second morning the two dogs were eating breakfast side by side and the cat played with Marigold's tail at the same time. Amazing!

In the past couple of months all of the shelter dogs have been alternating time in the CASA office while the shelter is open. As you may know, cats and kittens roam freely in the CASA office. Marigold has been enjoying her office time and has not had a single negative incident with the cats.

Marigold has mellowed and matured over the time she has spent at CASA. She is a more relaxed, well-behaved dog and is far more adoptable now than when she first got here. She will make some lucky family very happy. If you have been

considering adopting a mature, big dog please come see Marigold. She holds a special place in the hearts of the CASA staff members and volunteers. Although we will miss her terribly when she is adopted, we tell her every day what a great big beautiful dog she is and that maybe today will be the day she finds her Forever Home.



CASA, the Camano Animal Shelter Association, is a charitable, non-profit organization dedicated to the promotion of animal welfare and was established to provide care for the impounded dogs of Island County. CASA is responsible for the operation of the Camano Animal Shelter and receives limited funding from Island County in exchange for caring for dogs impounded on the island. CASA relies solely on donations for the care of all other animals, including all stray cats and dogs.

Is a "Free" Pet Really Free?

Often people ask, "Why should I pay a fee to adopt a pet? It's cheaper to get one that's free to a good home."

When you adopt a pet from CASA, these routine procedures and vaccines are included in the adoption fee. Currently our fees are \$135 for a dog or puppy (includes county fee of \$35) and \$100 for a cat or kitten. These fees also include a free vet consultation certificate. At CASA we provide the medical care and testing needed to give a kitten or puppy a great beginning. Not only are they given appropriate medical care - they are also well socialized. It starts with their loving foster families. Then they come to the shelter where they are exposed to other cats and dogs and people as well. Please encourage your friends to adopt an animal from CASA.


Should you decide to adopt a "free" dog or cat, please be a responsible owner and spay or neuter and vaccinate your pet. All animals deserve a caring and loving home.



Did You Know?

In 2008 472 cats and dogs arrived at CASA. We are proud that so many of these animals were either returned to their owners or found other loving homes.

Cat Stats: The vast majority of cats and kittens were brought in as strays (or born at the shelter). Of these, 81% have already found homes while others are waiting to be adopted (either at the shelter or at foster homes).

Dog Stats: Dogs brought to the shelter by the Animal Control Officers are called "impounds". Percentage-wise, more dogs were surrendered by their owners than cats. (30% of the dogs versus 25% of the cats). Fortunately 50% of the dogs were returned to their owners and 43% found other homes.



There is NO TIME LIMIT for an animal at CASA. In fact, some of our animals have been at the shelter since April. 2008. Kittens often have a high mortality rate and sometimes die in foster care or have to be put to sleep if they are very sick and suffering. Dogs are only put to sleep if they are terminally ill or too aggressive to be adopted.

CASA averages 55 animals a day either at the shelter or in foster care. As of the end of December, there were 32 animals waiting adoption. Keeping animals at a shelter often increases their stress, but at CASA the cats roam free and dogs are allowed to play outside with "yard buddies" and then rotated into the main office for socialization. Thanks to the loving care of staff and volunteers, these long-term residents remain happy and enthusiastic while waiting for their new Forever Homes.

Reasons to Call a Vet Immediately

Breathing Difficulties

Labored breathing especially when coupled with pale or bluish mucous membranes of the mouth and gums should be checked immediately. Honking, snorting and violent sneezing that does not stop on its own or any time the animal seems anxious associated with the above.

Serious Bleeding

Apply direct pressure to the wound. Get help if bleeding is not controlled in 10 to 15 minutes.



Major Trauma

If your pet has fallen, been struck by a moving vehicle, or suffers multiple wounds from an unseen accident, see a veterinarian even if the pet initially appears unharmed.

Lacerations and Bite Wounds

Wounds that penetrate the skin are contaminated and may become infected within several hours. Many wounds that seem minor externally often hide more extensive injuries to vital tissues below. Any bite from a wild animal should be taken very seriously.

Collapse or Loss of Consciousness/Seizures

Illness or injury can make your pet too weak to stand. Neurologic problems can impair or prevent normal movement and further attempts at walking may result in even greater injury. If you suspect your dog is having or has had a seizure, please call your vet immediately.



Prolonged vomiting or Diarrhea/Blood in Feces

Many diseases begin with vomiting and/or diarrhea. Regardless of the underlying cause, multiple episodes can lead to severe dehydration and shock.

Difficulty Urinating and Constipation

Be observant here. Attempting to urinate without normal urine flow may be an obstruction, which may lead to fatal uremic poisoning.

Infections

If you discover an infected wound or abscess, or if your pet suddenly becomes worse while on medications for infection, the infection may have spread and be causing toxicity.

Eye Problems

Redness, tearing, pain and eyelid spasms usually suggest an acute problem in one or both eyes. Such symptoms can go guickly from bad to worse.

Poisoning

When you know or suspect that your pet had ingested a poisonous substance, call immediately to receive emergency instructions and to assess the need for additional medical treatment. Animal Poison Control is 1-800-548-2423. Available 24 hours a day. (Fee for Service)




